If you are not in one of these jurisdictions, and you don't have an attorney, you can request a copy from the court that handled your divorce.

Divorce Decrees and Exemplifications. For information on obtaining a certified copy of a divorce decree and exemplification, please note: you must be a party to the action, attorney of record or have an affidavit or a notarized letter signed by a party to the action, granting you the authority to secure a copy of the divorce decree.

#### Obtaining Certified Copies | NYCOURTS.GOV

To get a copy of a divorce decree, contact the County Clerk. If the divorce was granted before January 1, 1963, the divorce decree is the only type of document available. Divorce Certificate. This document contains basic information about the spouses, and the date and place the marriage ended.

A certified copy of a divorce decree is a copy made by an officer of the court where the original document is stored. It is certified by the officer to be a true copy and is often stamped with the embossed seal of the court or state. A certified divorce decree may be necessary for legal matters when proof is required of a final divorce.

#### How to Get a Certified Copy of Divorce Decree | Law for ...

To receive a certified copy of your divorce record, you'll need your docket number. If you don't know what your docket number is, please call the Probate & Family Court where your case was heard to get your case docket number. Court staff will ask you for the case type, the first and last names of the parties, and the division the divorce was filed in so they can assist you.

#### Get a copy of your divorce record | Mass.gov

Divorce decrees can be obtained from the Circuit Clerk in the county where the divorce was granted. Only Certified Statements Relating to Marriage or Divorce can be obtained from the Bureau of Vital Records in Jefferson City. These statements list limited information such as names of individuals/parties, dates, and county of record.

Getting a copy of your divorce decree. To get a copy of your divorce decree, contact the court that handled the divorce case. Use the Court Directory to find contact information. The court provides copies of its records for a fee. There are situations where you may need the court to provide a certified or exemplified copy of a record.
