A slower pace of growth and easier monetary policy has resulted in investor preference for fixed rather than floating rate assets, as evidenced by fund outflows from bank loan funds and fund inflows into high yield bond funds (Exhibit 1). Investor demand alongside policy support has helped US high yield deliver a robust positive total return in excess of 12% year-to-date.

In round numbers, the historical default rate on high yield bonds is 4.5% per annum, and the average recovery rate is 45% of face value. That implies a required spread of $4.5\% \times (1 - 0.45)$, or about 250 bps. The historical average spread of the BofA Merrill Lynch High Yield Master II Index, however, is approximately 600 bps.

The great buying opportunities that arose when high-yield bonds sold off aggressively in the early days of the coronavirus shock have passed, but there is still value in the high-yield bond market. Large numbers of high-yield issuers have been hit very hard by the coronavirus shock, and some will never recover. One could see a default rate of 9% for the US high-yield market in 2020 and around 5% for the European high-yield market.

For that same reason, they are offered at a higher yield compared to investment grade bonds to compensate for the higher risk of holding onto the bond.

For instance, current spreads in US high yield imply a five-year cumulative default rate of about 40 per cent. Meanwhile, European high yield is currently pricing in a default rate of around 35 per cent, assuming the worst (i.e. zero recovery rates).
